

THE KENT BUILDING SUPPLIES GOLDEN GIVEAWAY - OFFICIAL RULES

The "KENT Building Supplies Golden Giveaway" (the "Game") is offered by KENT Building Supplies ("KENT") and is administered by WSP International Limited ("Administrators"). KENT hereinafter will be referred to as the "Game Sponsor". BMO Blue Rewards, Inc. is in no way connected to the management of the Game.

NO PURCHASE NECESSARY TO PLAY. Making a purchase will not improve your chances of winning.

General Game Information: The Game is being played at approximately 51 participating KENT locations ("Participating Locations") in the Canadian provinces of New Brunswick (NB), Nova Scotia (NS), Prince Edward Island (PE) and Newfoundland & Labrador (NL). Obtain a game ticket from any cashier or authorized personnel every time you make a qualifying purchase with a minimum \$50.00 spend before tax at a Participating Location during the Game Period while supplies last. For Online Orders: Tickets are given in-store if you placed an online order, please show your order confirmation email or receipt at the customer service desk to receive your ticket. Maximum one (1) game ticket per day per customer. Restrictions: Purchases of gift cards and purchases of warranty or extended warranty on appliances, do **not** qualify toward the \$50.00 purchase threshold required to receive a game ticket. You can obtain a game ticket without making a purchase by sending a self-addressed, stamped envelope to "KENT Golden Giveaway", P.O. Box 3009 M.I.P., Markham, ON, L3R 6G4. Requests must be received by April 22, 2026. Limit one (1) game ticket per request; one (1) request per outer mailing envelope; maximum one (1) requests per day during the Game Period (see section 1 – Game Dates below) per customer. 1) **GAME DATES:** The Game begins at 12:00:01 AM, Atlantic Time ("AT") or the start of business on April 2, 2026 (the "Game Start Date"). The Game is scheduled to end in-store at 11:59:59 PM AT or the end of business on May 6, 2026 (the "scheduled Game End Date") or whenever Game ticket supplies are exhausted, whichever occurs first. The period between the Game Start Date and the scheduled Game End Dates is known as the "Game Period". Certain components of the Game will end on different dates, as indicated elsewhere in these rules.

2) **WHO CAN PLAY:** The Game is open to all legal residents of the Canadian provinces of NB, NS, PE, and NL who have reached the age of majority, as of Game Start Date, in the province in which they reside. (The age of majority is 19 years in NB, NS and NL; 18 years in PE). B. PLAY ONLINE GAME: When the “Scratch to Reveal PIN” box on a game ticket is scratched, the ticket will reveal a unique PIN that may be used to enter the Online Sweepstakes. To enter, visit www.kentwin.ca any time after 12:00:01 a.m. AT on the Game Start Date and follow the onscreen instructions to complete the one-time electronic registration form.

A valid PIN is required to enter. Upon entry of a valid PIN, as indicated on the game ticket, the entrant will automatically receive between two (2) and ten (10) Online Sweepstakes ballots (“Online Ballots”). Online Ballot allocations are distributed in equal quantities.

C. PLAY FOR YOUR COMMUNITY: After entering a valid PIN during the Game Period, entrants will have the opportunity to nominate a registered charitable organization (each, a “Registered Charity”) by following the onscreen instructions during the Game. From Tuesday, May 12, 2026 at 12:00:01 a.m. AT to Sunday, May 31, 2026 at 11:59:59 p.m. AT (the “Community Voting Period”), entrants may visit www.kentwin.ca, follow the instructions to sign up or log in, and cast a vote for one (1) Registered Charity Finalist of their choice. Limit of one (1) vote per person per day during the Community Voting Period. Voting is free and no PIN is required to vote.

Voting Integrity / Fraud: The Game Sponsor reserves the right, in its sole discretion, to audit, review, and verify votes and voting activity to ensure the integrity of the voting process. Any votes that the Game Sponsor determines (in its sole discretion) to be the result of tampering, automated means (including bots, scripts, macros or other automated methods), vote manipulation, multiple accounts, false identities, mass voting, vote trading, or any other activity that undermines the intended operation of the Community Voting Period may be voided, and the associated voter(s) and/or Registered Charity nomination(s) may be disqualified. The Game Sponsor also reserves the right to remove or replace a Registered Charity Finalist at any time if it is determined to be ineligible, unverifiable, or associated with suspicious or prohibited voting activity.

On Wednesday, June 3, 2026, the Game Sponsor will determine the Registered Charity Finalist that received the highest number of eligible and verified votes during the Community Voting Period and will award that Registered Charity the \$50,000.00 Community Donation. In the event of a tie, the Game Sponsor reserves the right to apply a tie-breaking method in its sole discretion. The Community Donation will be awarded directly to the selected Registered Charity and is not transferable, assignable, or redeemable for cash by any individual entrant, and no individual entrant will receive any portion of the Community Donation.

4) NOTIFICATION AND REDEMPTION: For Instant Prizes and Discounts: All prize claims are subject to verification by Administrator and/or personnel authorized by the Game Sponsor at the Participating Location at which the prize claim is presented and surrendered for redemption (Rule 3 – WHAT TO DO WHEN YOU GET A TICKET WITH AN INSTANT WIN MESSAGE). **For Online Sweepstakes prizes:** If you have been selected as a potential winner in any of the drawings described above, the Game Sponsor or Administrator will notify you via email, postal mail, registered mail, courier and/or phone. - B) When in good faith we believe the law requires it.

- D) To affiliated companies, provided that our affiliated companies and their agents and advisors and their respective employees are restricted from using the information for any other purpose other than as described in these Official Rules; and

E) To our respective agents for data processing purposes, our respective professional advisors, and promotional and marketing agencies, provided that such agents, professional advisors, and promotional and marketing agencies are restricted from using the information for any purpose other than as described in these Official Rules.

Game Sponsor may match aggregated statistical use information to parameters established by third parties, without releasing user information. This information will not contain any personally identifiable information. Game Sponsor may share aggregate information with trading partners, co-branded locations, participating sponsors, and advertisers; however, this aggregated information will not contain personally identifiable information. Any requests for access to the information you have supplied, or to update or rectify your information must be made via email, accessible through www.kentwin.ca or by prepaid mail sent to "KENT Golden Giveaway, Box 3009 M.I.P., Markham, ON, L3R 6G4.

The Game Sponsor respects your right to privacy. Personal information collected from entrants will only be used by the Sponsor or its representatives to administer the Game. By entering the Game, entrant's consent to the manner of collection, use and disclosure of personal information as set out in the Sponsor's privacy statement, which is available at: www.KENT.ca/privacy.

8) RESTRICTIONS: The following are prohibited and will result in automatic disqualification from the Game: (1) using any method that artificially increases odds of winning; (2) non-compliance with these Official Rules; and (3) any other act which the Game Sponsor determines in its sole discretion, jeopardizes the integrity or proper conduct of the Game.
